## Assumption of the Risk, Release and Indemnification

I (we) the undersigned hereby request that the minor child named in the Registration Form above be granted permission to participate in the mutton bustin' and/or goat roping competition on the date(s) indicated, and as part of that participation be authorized to enter into all area(s) where the competitions and preparation for the competitions take place. Such areas include, without limitation, the rodeo arena, competition area, preparation area, chutes, pens, adjacent walkways, and all such other areas as are related to the mutton bustin' and/or goat roping competitions. In consideration of the grant of such permission, I (we), on our own behalf and on behalf of the minor child and his/her parents, personal representatives, heirs, next of kin, and assigns, do hereby agree as follows:

**Assumption of the Risk.** I (we) understand and acknowledge that entry into these areas and participating in the mutton bustin' and/or goat roping competitions is inherently dangerous and carries with it the risk of serious injury or death. I (we) assume all risk of injury or death of the minor child which may result from or be related to his/her preparation for and participation in the competitions.

**Release and Indemnification.** I (we), on our own behalf and on behalf of the minor child and his/her parents, personal representatives, heirs, next of kin, and assigns, do hereby release, indemnify, hold harmless and forever discharge the following entities and parties from and against any and all claims arising from or related to the minor child's preparation for and participation in the mutton bustin' and/or goat roping competitions: Pikes Peak Mutton Busters, Dave Arnold, NPEC LLC d/b/a Norris Penrose Event Center, Colorado Springs Rodeo Association, Inc., the Pikes Peak or Bust Rodeo, the Pikes Peak or Bust Rodeo Foundation d/b/a the Pikes Peak or Bust Foundation, the Norris Penrose Legacy Foundation, the Professional Rodeo Cowboy's Association, Inc., and each and all of their respective affiliates, officers, directors, managers, members, employees, releasees, sponsors and volunteers (collectively, the "Released Parties").
